- In case the full fees is not paid by the due date, the amount paid towards the provisional admission shall stand forfeited and Institute shall not be held responsible.
- Fees is payable in advance for all courses. Any amount paid is not refundable for any reason whatsoever.
- Fee shall be payable for such period, for which the student is absent/on leave from the institute.
- Student is not allowed to change the course.
